SHOW RULES

- All regulations required for organizing and realisation of special european club exhibitions apply. These comply under the rabbit division, such as exhibited regulations in this document.
- Exhibition is being organized by Slovakian Lop – breeders club in cooperation with SZCH. Director of exhibition: Martin Pavlák, Pružina 545, 01822, tel: +421 918 407 858, email: martin.pavlak87@gmail.com . Deputy director : Ing. Norbert Králik, Vitálišovce 1016, 03104 Liptovský Mikuláš .
- All breeders under EE association have its right to participate in exhibition, after all necessary conditions have been fulfilled towards national association (member of EE organisation and its underlying organisations.)
- Applications for participation in exhibition can be submitted online through www.onlinevystava.eu/ee2024 website or via e-mail baranyklub.sk@gmail.com
- Confirmation receipt of application will be sent to exhibitor via e-mail. Applications can be submitted since 30.8.2024. Changes in applications (tattoo, gender, buy price are allowed via email or online registration until 12.11.2024. Changes in breed or colour variety are not allowed after registration.
- By the rules of EE it is possible to exhibit collection of four rabbits, as well as individual rabbits of both genders. All lop – eared breeds are allowed, when fulfilling the European standarts.
- Competition expositions – A) Junior breeders B) General class
- Title Master Of Europe is awarded to four piece collections with overall highest acquired points. Atleast 20 animals of single breed and specific colour has to be exhibited to award the title. If there is less than 20 animals of single breed with same specific color then this group will be merged with different specific colour group (of the same breed) containing aswell less than 20 exhibited animals to award the title. In case of participants acquiring equal number of points title will be awarded to both or more of the participants. As a proof of awarded title , diplomas will be distributed. In Junior Breeders class same conditions and rules apply as in General Class. Only exemption is that Junior breeders class are required to exhibit only 10 animals, not 20 animals as is the requirement in General Class.
- With condition of atleast 20 exhibited animals of same breed, specific colour or merged group of different specific colour (within the same breed) title Champion of Europe is going to be awarded to the individual according to the highest acquired points. There will be no differentiation between genders,as both male and female gender will be equally examined under one title . If there is more than 40 animals of same breed and same specific breed colour then both male and female gender will have its own title awarded. Same conditions apply for Junior breeders class and its title Champion of Europe, but with same exemption as described above. Number of animals required for title to be awarded are halved in comparation with General Class.
- Every exhibitor will be rewarded with souvenir.

Exhibition fees::

Cage fee : 9,00 €
Administration fee 9,00 €
Catalogue 6,00 €

- Catalogue fee is mandatory for every exhibitor. Bowls necessary for water and fodder will be arranged by organizer of exhibition. Fees connected with exhibition need to be paid in advance via bank transfer. Applications without paid fees will not be accepted.

- If the exhibition cannot take place due to force majeure or similar circumstances, the exhibition fees will be refunded after deducting the incurred costs.
- Sale of animals will take place exclusively through exhibitions cash register system.

Buyer pays the selling price plus a 10 percent surcharge, which goes in favor of the exhibition. Purchased animals will be handed out to buyers at 16.11.2024 from 9:00.

No vaccinations are required. Each breeder needs veterinarian's confirmation about clinical health of his rabbits.

- By submitting an application for the exhibition, the exhibitor, or legal representative, agrees to the publication and use of personal data in the catalog (name, address, telephone number and identification data of exhibited animals). In addition, the organizer can publish these data, exhibition results and photos on the websites of the respective clubs and associations.
- According to EE regulations, it is not possible to appeal against the exclusion of animals at a European exhibition.
- If a dispute between exhibitors and the management of the exhibition arises, there cannot be any further legal action. The management of the exhibition will make the final decision in cooperation with the organizer. If the animal suffers damage caused by the organizer's actions, the exhibitor is entitled to compensation. Claims for compensation for losses caused by force majeure or unforeseen events cannot be submitted.
